## Proxy Applications (Open 9am 3 Sept. Close 7am 23 Sept.)



- 1 **Download** proxy application from website:  
[www.election.com.nr/for-voters](http://www.election.com.nr/for-voters)
- 2 **Complete** proxy form – fill in all necessary details.
- 3 **Check** that the person you nominate to be your proxy is registered in the same district as you.
- 4 **Witness:** Page 2 of the application, has a list of authorised witnesses who can witness your proxy application.
- 5 **Email:** After completing the form, scan & send it to:  
[helpdesk@electoralcommission.org.nr](mailto:helpdesk@electoralcommission.org.nr)
- 6 **Ask your Proxy** to come into NEC to sign their **consent** part of the form (Page 3 of application).
